

As the use of MEWP's can be physically demanding, users should be physically fit, in good health If you have any problems or you have any doubts about your fitness to use MEWP's, you must bring them to the attention of your employer. This need not preclude you from using MEWP's, provided your employer conducts an assessment and is able to put in place adequate measures to take account of any difficulties you may have.

The aim of ALLMI training is to raise the standard of lorry loader operators and instructors throughout the UK. This is achieved by providing a comprehensive training programme for operators of lorry loaders as well as accreditation for instructors.

The ALLMI approved training programme is designed to meet employers' and employees' responsibilities under the Health and Safety at Work Act 1974, as well as the requirements of all other legislation relating to the operation of lorry loaders.

Slinger / Signaller Training

The approved ALLMI Slinger / Signaller course content is very comprehensive and so cardholders are able to use their skills when performing Slinger / Signaller duties with any type of lifting equipment, not just lorry loaders. The Slinger / Signaller course consists of 13 modules. The course duration is one day for experienced candidates and a minimum of two days for novice candidates. A maximum of four candidates can attend a course. Both courses culminate in a written and practical examination.

Upon successful completion of the course every candidate will receive an identity card and certificate, and will be registered on the ALLMI & JJ Training database. The certificate and identity card are valid for five years, after which time refresher training and assessments will need to be undertaken. Candidates also receive the ALLMI Slinger / Signaller manual, which is used as a reference guide throughout their career.

The strength of ALLMI training comes from the technical and training knowledge on its Training Standards Committee. The Committee is made up of training and technical professionals from all the major loader crane manufacturers and importers within the UK. In addition, the Health and Safety Executive is represented. The Committee develops, consults upon and maintains all the training standards set by ALLMI.

The ALLMI Slinger / Signaller course is approved by CSCS.

Regardless of whether you already hold these licences you will be obliged to commit to 35 hours of training on a rolling 5-year basis.

From September 10th, 2009, all commercial LGV Drivers will need to complete 35 hours of training before 9th September 2014 and hold a Driver CPC in addition to their vocational licence.

If you are a new LGV driver taking a test in either category C1 or C after 10th September 2009 you will need to pass all 4 modules of the Driver CPC to be able to driver commercially

Plant Operations NVQ



The Level 2 NVQ/QCF in Plant Operations (ProQual) qualification is competence-based and candidates must demonstrate the level of competence described in the units. The qualifications will be assessed

in a work environment and in accordance with the ConstructionSkills' Consolidated Assessment Strategy for Construction and the Built Environment, and it will be internally assessed by an appropriately experienced and qualified assessor. Each candidate is required to produce a portfolio of evidence which demonstrates their achievement of all of the learning outcomes and assessment criteria for each unit. The awarding body for this qualification Level 2 NVQ/QCF in Plant Operations (ProQual) is ProQual Awarding Body and the regulatory body is the Office of Qualifications and Examinations Regulation (Ofqual) and is also endorsed by the sector body for construction - CITB. The qualification has been accredited onto the Regulated Qualifications Framework (RQF) and is published on Ofqual's Register of Qualifications
